Executive Summary

The purpose of the Jonesboro Police Department Monthly Report is to compile data into one integrated report for review, allowing for a seamless flow of information for better decision-making. After each department collates their monthly numbers and sends it to Crime Analysis, it is organized into sections of departmental data, analyzed and packaged, and finally disseminated to department heads, the Chief of Police, the City Mayor, and the City Council. Major sections include Crime Analysis, Emergency 911, Uniform Police Division, Prowl, Criminal Investigative Division, Warrants, Drug Task Force, Traffic, Parking Enforcement, Animal Control, Fleet Maintenance, Records, and Professional Standards.


Crime Analysis

The Crime Analysis division consists of a Crime Analyst and an assistant. The Crime Analyst position is responsible for the analysis and dissemination of crime activity data and the collection and maintenance of crime intelligence information for the city of Jonesboro. Additionally, the Crime Analyst is charged with providing the department with current and accurate crime maps, presenting crime activity data to audiences of interest, and responding to requests for crime data from civilians and departmental staff. Data exported from this division is used by field agents for more effective, efficient policing, administration for improved staffing decisions, and the Mayor's office for community decision making and enhanced public relations. This section is broken down by 6 sections: total crime, crimes against persons, property crimes, crimes of proactive policing, other crimes, and arrest demographics.


Total Crime

The crime activity for this month is at a total of 1,579 offenses, up from 1,256 offenses last March, a 26% increase. Other crimes absorb the majority of this month's crime activity at 59% (n = 925). Property crimes fall in second place with 29% (n = 454). Following in third and fourth places are crimes of proactive policing at 11% (n = 179), and crimes against persons with only 2% (n = 95).


Year to date data includes January, February, March, and April data combined, of which there is a total of 5,967 offenses, up from 4,652 last April, a 28% increase. Again, other crimes has the highest percentage to total crimes at 59% (n = 3,515). Similar to this month's data, property crimes take second place at 28% (n = 1,685). Following are the crimes of proactive policing at 11% (n = 672) and crimes against persons at 2% (n = 95).



Crimes against Persons


There are 8 crimes that make up this section. There were a total of 21 offenses in this area this month, down from 34 last April, a 38% decrease. The following chart demonstrates this month's activity compared to April of last year's activity in all 8 areas. All 8 crimes in this area are either equal or less than to what they were April 2009. Significantly lower are the aggravated assaults down to 14 from 21, a 33% decrease. Also, kidnappings have decreased from 3 to 0. It should be

noted that Arkansas State University had 1 murder on campus this month; however, this is not reflected in this monthly report, as ASU is responsible for reporting their crime statistics.

Below is a bar graph indicating the year to date data for crimes against persons. Total number of year to date crimes against persons is 95, down from 106 last April. Although year to date robberies are down 55%, aggravated assault offenses are up 15% and rape is up by 2.


Property Crimes

This section displays the criminal activity for 18 crimes, all against property. This month, there were a total of 454 property crimes, down from 531 last April. This is a 15% decrease in



property crimes from last April. Crimes in this category that are noticeably lower than last April are larceny, burglary, vandalism, shoplifting, and theft from buildings. Significantly higher are thefts from motor vehicles.




To date this year, 1,685 property offenses have occurred, down from 1,906 last year at this same time. This is a 12% decrease in property crimes from this time last year. Those crime areas that are down include larceny, burglary, vandalism, shoplifting, and theft from buildings. A few crimes have increased, such as, bad checks, counterfeiting, credit card fraud, swindling, and theft from motor vehicles.




Crimes of Proactive Policing

Crimes of proactive policing are those crimes that result from police officers actively policing the streets to combat certain types of street crime. Twelve crimes fall under this category. A total of 179 offenses have occurred this month, a 10% increase from last April (n = 162).

Significantly higher are DUI offenses (48%), drunkenness (83%), and trespassing (40%). Significantly lower are drug/equipment violations (56%) and drug/narcotic violations (35%).




To date for the year, there have been 672 crimes of proactive policing. This is up from 600 last April, an 12% increase. Increases to date include curfew, disorderly conduct, DUI, drug/equipment violations, drunkenness, and liquor law violations. Decreases include pornography, trespassing, and weapon law violations.




Other Crimes

There are 10 crimes that fall into the other crimes category. This month, there have been a total of 925 other crimes up from 529 last April, a 75% increase. All other offenses are significantly higher than last April by 94%. Most other crimes in this area remain stable.




To date this year, there have been 3,515 other crimes, up from 2,040 last April, a 72% increase. The largest increase occurred, similar to above, in the all other offenses area (n = 3,105), which accounts for a 92% increase. Another increase includes intimidation by 11%. Simple assaults decreased by 5% and runaways decreased by 26%.



Arrest Demographics


This section will break down race and gender for the 807 arrests this month. The majority of offenders have been male (n=548), as opposed to female (n=259) and Caucasian (n=425) and African American (n=351) as opposed to Hispanic (n=29), Asian (n=0), or other/unknown/biracial (n=2).

Caucasian males make up the majority of offenders for the month of April, totaling 33% (n = 264). African American males account for 32% (n = 259) of the offenders this month. White females make up 20% (n = 161) and African American females make up 11% (n = 92). The remaining 4% is made up of Hispanic males and females. This distribution can be reviewed in the pie chart below.

Emergency 911

Also known as Public Safety Answering Point (PSAP), the Emergency 911 Division is responsible for answering all calls from public for emergency assistance, accessing the needed information to best assist, and then assigning the most efficient and effective emergency response. In addition, this division is responsible for setting priority call dispatching to field units including Police, Fire, and EMS. Emergency 911 also maintains all records for radio logs, calls for service, and other emergency service data collections.

Officers from UPD are assigned to a district and work the same district every shift. In addition, when a Traffic Officer is not available, a UPD Officer will respond to traffic accidents and assist in directing traffic when necessary.

Warrants

The Warrants Division is responsible for serving warrants, criminal summonses, and subpoenas that are issued by the District Court. On city court days, the Warrants Division provides a bailiff for court and a transport officer. In addition, this Division is responsible for transporting wanted persons arrested in other jurisdictions back to Jonesboro. The STEP program operates within this

division and is a grant-funded operation in which officers can get paid overtime to enforce the safety belt law.




