

EXECUTIVE SUMMARY

The purpose of the Jonesboro Police Department Monthly Report is to compile data into one integrated report for review, allowing for a seamless flow of information for better decision-making. After each department collates their monthly numbers and sends it to the Office of Crime Analysis, it is organized into sections of departmental data, analyzed and packaged, and finally disseminated to department heads, the Chief of Police, the City Mayor, and the City Council. Major sections include Crime Analysis, Emergency 911, Uniform Police Division, Prowl, Criminal Investigative Division, Warrants, Drug Task Force, Traffic, Parking Enforcement, Animal Control, Fleet Maintenance, Records, and Professional Standards.


CRIME ANALYSIS

The Crime Analysis division consists of one Crime Analyst and one part-time Crime Analyst Assistant. The Crime Analyst position is responsible for the analysis and dissemination of crime activity data and the collection and maintenance of crime intelligence information for the city of Jonesboro. Additionally, the Crime Analyst is charged with providing the department with current and accurate crime maps, presenting crime activity data to audiences of interest, and responding to requests for crime data from civilians and departmental staff. Data exported from this division is used by field agents for more effective, efficient policing, administration for improved staffing decisions, and the Mayor's office for community decision making and enhanced public relations. The following section is broken down into Total Crime, Crimes against Persons, Property Crimes, Crimes of Proactive Policing, Other Crimes, and Arrest Demographics.


TOTAL CRIME

The crime activity for the month of August 2011 is at a total of 1,732 offenses, an insignificant increase from 1,724 offenses in August 2010. With Jonesboro population equal to 67,263, the crime rate is 25.75 crimes per 1,000 population for the month of August this year, compared to the 26.78 crimes per 1,000 population last year, a less than 0.5% increase*. As indicated on a pie chart on the following page, Other Crimes absorb the majority, 50%, of this month's crime activity (n = 866). Property crimes fall into a second place and comprise 36% of all the crimes (n = 628). Following in third and fourth places are crimes of proactive policing at 12% (n = 197) and crimes against persons at 2% (n = 41).




Year to date data includes number of crimes from January through August of this year, of which there is a total of 13,579 offenses, up from 12,811 offenses that occurred through August of last year, a 6% increase in both crime frequency and in crime rate per 1,000 population. Again, Other Crimes have the highest percentage of total crimes and are at 56% (n = 7,627). Property Crimes comprise 31% of total crimes to date where, n = 4,260. Crimes of Proactive Policing amount to 11% (n = 1,448) and crimes against persons comprise 2% of total year to date number of crimes (n = 204).




CRIMES AGAINST PERSONS

There are 9 crimes that make up this section. There were a total of 41 offenses in this area this month, a 37% increase, compared the last year's total in August. As demonstrated on the following chart, Aggravated Assault is higher by 41% this month and Robbery increased by a total of 8 incidents. There was one offence in a category of Murder and Nonnegligent Manslaughter committed in the month of August. There are no significant changes in other crimes for this category.




Bellows bar graph shows the year to date data for Crimes against Persons. Total number of year to date Crimes against Persons this year is 244, up 14% compared to August of last year. This is due to the increase in a total number of Robberies, 48% up, and Forcible Rape, 29% up to date this year.




PROPERTY CRIMES

This section displays the criminal activity for 18 crimes, all against property. This month, there were a total of 628 Property Crimes, an 18% increase comparing to August of last year. The data indicates a significant change in Counterfeiting/Forgery, 57% down. All Other Larceny is up by 12%, Burglary/Breaking and Entering is up by 12%, Destruction/Damage/Vandalism of Property is up by 19%, and Theft from Building is up by 14% compared to August of last year.




To date this year, 4,260 property offenses have occurred, a 6% increase compared to last year's data at this same time. Comparing to the frequencies of offenses with last year's data, there is a 14% decrease in Bad Checks, 17% decrease in Counterfeiting/Forgery and in False Pretenses/Swindle/Confidence Game each. Comparing to last year's to date frequencies of offenses in this category, Motor Vehicle Theft increased by 76%, Shoplifting increased by 39%, and Arson by 117%.




CRIMES OF PROACTIVE POLICING

Crimes of Proactive Policing are those crimes that result from police officers actively policing the streets to combat certain types of street crime. As chart below indicates, twelve crimes fall under this category. A total of 197 offenses have occurred this month, a 2% increase, comparing to August of last year. Although there are no statistically significant changes, there is an increase in Drunkenness offenses, 33% up and in Driving Under Influence, 22% up. Drug/Equipment Violations decreased by 50%.




To date for the year 2011, there have been 1,377 crimes of proactive policing, up 5% from last year's to date offenses. Disorderly Conduct Offenses are up by 21%, Drug/Narcotic violations increased by 30%. Weapon Law Violations are up 23%. We are seeing a drop in Driving Under Influence and in Drunkenness, 7% and 11 % down, respectively, and in Trespass of Real Property, 16% down.




OTHER CRIMES

There are 10 crimes that fall into the Other Crimes category. This month, there have been a total of 866 Other Crimes, down from 970 in August of last year, an 11% decrease. Intimidations are up by 16%. All other violations in this category are down this month. Simple Assaults decreased by 12% and All Other Offenses within Other Crimes categories decreased by 6%.




To date this year, there have been 7,627 Other Crimes offenses up from 7,196 as of last year's to date offenses, a 6% increase. Simple Assaults are up 12% and All Other Offenses within the Other Crimes category are up 6%, compared to last year's data.





ARREST DEMOGRAPHICS


In August, there were a total of 859 arrests, as opposed to 972 arrests in August last year, a 12% decrease; that is .5 arrests per crime in August of this year, comparing to .56 arrests per crime last year, resulting in a 12% decrease in arrests per crime as well.

This section breaks down this month's arrests by race and gender. The majority of offenders have been male (n = 577), as opposed to female (n = 282) and Caucasian (n = 452) and African American (n = 374) as opposed to Hispanic (n = 26), Asian (n = 1), or other/unknown/bi-racial (n = 6).










Caucasian males make up the majority, 33%, of arrestees this month (n = 284). African American males make up 31% of arrestees for the month of August (n = 269). Caucasian females make up 20% (n = 168) and African American females make up 12% (n = 105). Hispanic males make up 2% (n = 19). There were also 4 Other/Biracial Males, 7 Hispanic Females, 2 Other/Biracial Females, and 1 Asian Male arrested in the month of August. EMERGENCY 911

Also known as Public Safety Answering Point (PSAP), the Emergency 911 Division is responsible for answering all calls from public for emergency assistance, accessing the needed information to best assist, and then assigning the most efficient and effective emergency response. In addition, this division is responsible for setting priority call dispatching to field units including Police, Fire, and EMS. Emergency 911 also maintains all records for radio logs, calls for service, and other emergency service data collections.

UNIFORM PATROL DIVISION

The UPD is responsible for responding to calls into the Emergency – 911 Division by civilians and are normally the first responders. Jonesboro is divided into 6 patrol districts. Officers from UPD are assigned to a district and work the same district every shift. In addition, when a Traffic Officer is not available, a UPD Officer will respond to traffic accidents and assist in directing traffic when necessary.

On city court days, the Warrants Division provides a bailiff for court and a transport officer. In addition, this Division is responsible for transporting wanted persons arrested in other jurisdictions back to Jonesboro. The STEP program operates within this division and is a grant-funded operation in which officers can get paid overtime to enforce the safety belt law.




TRAFFIC
