Executive Summary


The purpose of the Jonesboro Police Department Monthly Report is to compile data into one integrated report for review, allowing for a seamless flow of information for better decision-making. After each department collates their monthly numbers and sends it to Crime Analysis, it is organized into sections of departmental data, analyzed and packaged, and finally disseminated to department heads, the Chief of Police, the City Mayor, and the City Council. Major sections include Crime Analysis, Emergency 911, Uniform Police Division, Prowl, Criminal Investigative Division, Warrants, Drug Task Force, Traffic, Parking Enforcement, Animal Control, Fleet Maintenance, Records, and Professional Standards.

Crime Analysis

The Crime Analysis division consists of a Crime Analyst and an assistant. The Crime Analyst position is responsible for the analysis and dissemination of crime activity data and the collection and maintenance of crime intelligence information for the city of Jonesboro. Additionally, the Crime Analyst is charged with providing the department with current and accurate crime maps, presenting crime activity data to audiences of interest, and responding to requests for crime data from civilians and departmental staff. Data exported from this division is used by field agents for more effective, efficient policing, administration for improved staffing decisions, and the Mayor's office for community decision making and enhanced public relations. This section is broken down by 6 sections: total crime, crimes against persons, property crimes, crimes of proactive policing, other crimes, and arrest demographics.


Total Crime

The crime activity for this month is at a total of 1,487 offenses, up from 1,233 offenses last January, which is an 21% increase. Other crimes absorb the majority of this month's crime activity with over half at 58%. Property crimes fall in second place with 29%. Following in third and fourth places are crimes of proactive policing with 11% and crimes against persons with only 2%. Since it is only one month into the year, all year to date data will be the same as this month's data; therefore, will not be reported separately.




Crimes against Persons

There are 8 crimes that make up this section. The following chart demonstrates this month's activity compared to January of last year's activity in these areas. Overall, there were 25 crimes against persons this month, down from 29 last January (down 14%). Only two crimes are up in this category. Kidnapping is up to 1 from 0 and forcible rape up from 1 to 5. All other crimes are down or the same. Significantly lower by 50% was robbery, down to 5 from 10 last January. There were no homicides this month.




Property Crimes

This section displays the criminal activity for 18 crimes, all against property. There have been 438 property crimes this month, down 17% from last January (n = 527). Significant increases from last January include a 143% increase in bad checks and a 62% increase in forgery. However, most property crime has decreased, stayed the same, or barely increased from January 2009. Significant decreases include burglary (-34%) and theft from building (-32%).



Crimes of Proactive Policing


Crimes of proactive policing are those crimes that result from police officers actively policing the streets to combat certain types of street crime. Twelve crimes fall under this category. A total of 156 offenses have occurred this month, up 16% from last January (n = 134). As indicated in the chart below, all crimes in this area are either up or the same as January 2009, with the exception of trespassing (down 50%) and weapon law violations (down 67%). Increases in officer initiated crimes could be interpreted by more offenses being committed, but more probable is that officers have been more actively seeking out these particular violators versus just coming across them as traffic stops occur. Significant increases this month include drug & narcotic violations (up 42%) and drunkenness (up 20%).



Other Crimes


There are 10 crimes that fall into the other crimes category. There were a total of 868 offenses in this category this month, up from 543 last January (a 60% increase). Half are at 0 occurrences, the same as last January. Three are up in incidents. These crimes are impersonation (up to 1 from

0), all other offenses (up 76%), and simple assaults (up 11%). Crimes that decreased from January 2009 are intimidation (down 14%) and runaway (down 50%).




Arrest Demographics

This section will break down race and gender for the 804 arrests this month. The majority of offenders have been male (n=552), as opposed to female (n=252) and Caucasian (n=414) and African American (n=359) as opposed to Hispanic (n=24), Asian (n=2), or other/unknown/biracial (n=5).



*Although the chart indicates a 0% for Asian arrestees, the number is actually 2; however, 2 of 796 comes out to .002%.

Caucasian males and African American males make up the majority of offenders for the month of January, totaling 65%. White females make up 18% and African American females make up 13%. The remaining 5% can be reviewed in the pie chart below.



Emergency 911

Also known as Public Safety Answering Point (PSAP), the Emergency 911 Division is responsible for answering all calls from public for emergency assistance, accessing the needed information to best assist, and then assigning the most efficient and effective emergency response. In addition, this division is responsible for setting priority call dispatching to field units including Police, Fire, and EMS. Emergency 911 also maintains all records for radio logs, calls for service, and other emergency service data collections.

Uniform Patrol Division

The UPD is responsible for responding to calls into the Emergency -911 Division by civilians and are normally the first responders. Jonesboro is divided into 6 patrol districts. Officers from UPD are assigned to a district and work the same district every shift. In addition, when a Traffic Officer is not available, a UPD Officer will respond to traffic accidents and assist in directing traffic when necessary.

There were a total of 9,879 incidents of which UPD responded this month. Over half of these were calls for service (n = 6,370). 1,738 arrests were made and 863 traffic citations were written. There were 60,987 miles driven and a total of 9,430 hours worked.

Prowl

The Prowl unit is a uniformed street crimes unit specializing in criminal patrol, narcotics enforcement, gang investigation, and prostitution activity. The unit conducts directed patrols, investigates citizen complaints of street-level criminal activity, and directly assists the 2nd Judicial Drug Task Force. PROWL also assists any division within the Jonesboro Police Department at any time when needed.

Prowl had 101 calls for service this month. There were 90 arrests made and 23 traffic citations written. The total value of drugs seized was \$3,440 and 5,250 miles were driven.

Warrants

The Warrants Division is responsible for serving warrants, criminal summonses, and subpoenas that are issued by the District Court. On city court days, the Warrants Division provides a bailiff for court and a transport officer. In addition, this Division is responsible for transporting wanted persons arrested in other jurisdictions back to Jonesboro. The STEP program operates within this division and is a grant-funded operation in which officers can get paid overtime to enforce the safety belt law.

The Warrants division handled 983 arrests this month and 568 subpoenas. This unit served 2,323 total warrants this month and collected a total of \$18,406.93 in fines and fees.

Drug Task Force

The DTF is responsible for investigating major drug traffickers in the area, including all types of illegal drugs. They work closely with local, state, and federal agencies to eradicate drugs from the community.

DTF opened a total of 29 investigations this month, closed 19, and had 45 arrests. The majority of offenders were Caucasian (52%) and male (78%).



Traffic

Comprised of three motor units and three Chargers, the Traffic Enforcement Unit responds to traffic accidents and provides increased enforcement in particularly challenging areas. This unit also provides extra coverage for specific congestion problems and special events in the community. Last, they work details targeting specific issues, such as DWI enforcement and traffic safety checkpoints.

The Traffic division handled 931 incidents this month, drove 5,389 miles, and worked 794 hours. This is a 33% increase in work from last month in only a 23% increase in work time. The 181 traffic accidents that occurred this month are mapped below.
