# **Executive Summary**


The purpose of the Jonesboro Police Department Monthly Report is to compile data into one integrated report for review, allowing for a seamless flow of information for better decision-making. After each department collates their monthly numbers and sends it to Crime Analysis, it is organized into sections of departmental data, analyzed and packaged, and finally disseminated to department heads, the Chief of Police, the City Mayor, and the City Council. Major sections include Crime Analysis, Emergency 911, Uniform Police Division, Prowl, Criminal Investigative Division, Warrants, Drug Task Force, Traffic, Parking Enforcement, Animal Control, Fleet Maintenance, Records, and Professional Standards.

## **Crime Analysis**


The Crime Analysis division consists of a Crime Analyst and a Crime Analyst Assistant. The Crime Analyst position is responsible for the analysis and dissemination of crime activity data and the collection and maintenance of crime intelligence information for the city of Jonesboro. Additionally, the Crime Analyst is charged with providing the department with current and accurate crime maps, presenting crime activity data to audiences of interest, and responding to requests for crime data from civilians and departmental staff. Data exported from this division is used by field agents for more effective, efficient policing, administration for improved staffing decisions, and the Mayor's office for community decision making and enhanced public relations. This section is broken down into total crime, crimes against persons, property crimes, crimes of proactive policing, other crimes, and arrest demographics.

#### **Total Crime**

The crime activity for this month is at a total of 1,641 offenses, up from 1,421 offenses last July, a 15% increase. Other crimes absorb the majority of this month's crime activity at 53% (n = 871). Property crimes fall in second place with 35% (n = 570). Following in third and fourth places are crimes of proactive policing at 10% (n = 173), and crimes against persons with only 2% (n = 27).




Year to date data includes January through July, of which there is a total of 10,991 offenses, up from 8,894 last July, a 24% increase. Again, other crimes has the highest percentage to total crimes at 56% (n = 6,184). Similar to this month's data, property crimes take second place at 31% (n = 3,448). Following are the crimes of proactive policing at 11% (n = 1,178) and crimes against persons at 2% (n = 181).




## **Crimes against Persons**

There are 8 crimes that make up this section. There were a total of 27 offenses in this area this month, up just 1 from last July, a 4% increase. The following chart demonstrates this month's

activity compared to July of last year's activity in all 8 areas. Significantly lower are the aggravated assaults down to 11 from 17, a 35% decrease. Also, kidnappings are down by 2.




Below is a bar graph indicating the year to date data for crimes against persons. Total number of year to date crimes against persons is 181, down from 204 last July, a 11% decrease. Robberies are down 27% from this time last year, fondling is down by 50%, and sexual assault with an object is down by 1.




\*Arkansas State University had 1 murder on campus in April, but this statistic is reported by ASU and not the City of Jonesboro.

# **Property Crimes**

This section displays the criminal activity for 18 crimes, all against property. This month, there were a total of 570 property crimes, a 2% increase from 580 last July. Shoplifting is down by 37%, theft from motor vehicle is down 39%, and motor vehicle theft is down by 55%.




To date this year, 3,448 property offenses have occurred, down from 3,545 last year at this same time. This is a 3% decrease in property crimes from this time last year. Significant decreases include shoplifting (27%), theft from building (11%), motor vehicle theft (31%), gambling (100%), and purse snatching (33%).




# **Crimes of Proactive Policing**

Crimes of proactive policing are those crimes that result from police officers actively policing the streets to combat certain types of street crime. Twelve crimes fall under this category. A total of 173 offenses have occurred this month, a 3% decrease from last July (n = 179). Significant changes include disorderly conduct (down 28%), DUI (down 45%), drug/equipment violations (down 18%), drug/narcotic violations (down 11%), drunkenness (up 74%), trespassing (up 35%), and weapon law violations (up 17%).




To date for the year, there have been 1,178 crimes of proactive policing. This is down from 1,199 last July, a 2% decrease. Significant changes include curfew (up 114%), drug/narcotic violations (down 15%), drunkenness (up 20%), gambling (down 100%), liquor law violations (down 18%), pornography (down 14%), prostitution (down 100%), and weapon law violations (down 20%).




## **Other Crimes**

There are 10 crimes that fall into the other crimes category. This month, there have been a total of 871 other crimes up from 636 last July, a 37% increase. All other offenses are significantly higher than last July by 48%. Simple assaults are down by 32% and runaways are down 14%.





To date this year, there have been 6,184 other crimes, up from 3,946 last July, a 57% increase. The largest increase occurred, similar to above, in the all other offenses area (n = 5,444), which accounts for a 73% increase.





# **Arrest Demographics**

This section will break down race and gender for the 865 arrests this month. The majority of offenders have been male (n=624), as opposed to female (n=241) and Caucasian (n=453) and African American (n=372) as opposed to Hispanic (n=30), Asian (n=1), or other/unknown/biracial (n=9).










Caucasian males make up the majority of offenders for the month of June, totaling 36% (n = 311). African American males account for 32% (n = 277) of the offenders this month. Caucasian females make up 17% (n = 142) and African American females make up 11% (n = 95). The remaining 4% is made up of Hispanic males and other/bi-racial males. This distribution can be reviewed in the pie chart below (see page 9).



<sup>\*</sup>Although the chart indicates a 0% for Hispanic female (n=2) Asian Male (n=1), and other/bi-racial females (n=2) arrestees, the percentage is so small that excel rounds it to 0%.

# **Emergency 911**

Also known as Public Safety Answering Point (PSAP), the Emergency 911 Division is responsible for answering all calls from public for emergency assistance, accessing the needed information to best assist, and then assigning the most efficient and effective emergency response. In addition, this division is responsible for setting priority call dispatching to field units including Police, Fire, and EMS. Emergency 911 also maintains all records for radio logs, calls for service, and other emergency service data collections.

# **Uniform Patrol Division**

The UPD is responsible for responding to calls into the Emergency -911 Division by civilians and are normally the first responders. Jonesboro is divided into 6 patrol districts. Officers from UPD are assigned to a district and work the same district every shift. In addition, when a Traffic Officer is not available, a UPD Officer will respond to traffic accidents and assist in directing traffic when necessary.

PROWL also assists any division within the Jonesboro Police Department at any time when needed.

#### **Warrants**

The Warrants Division is responsible for serving warrants, criminal summonses, and subpoenas that are issued by the District Court. On city court days, the Warrants Division provides a bailiff for court and a transport officer. In addition, this Division is responsible for transporting wanted persons arrested in other jurisdictions back to Jonesboro. The STEP program operates within this division and is a grant-funded operation in which officers can get paid overtime to enforce the safety belt law.

The Warrants Division generated \$17,203.67 from district court in the month of July. They quashed 80 total warrants, issued 3,143, and served 2,350.




