

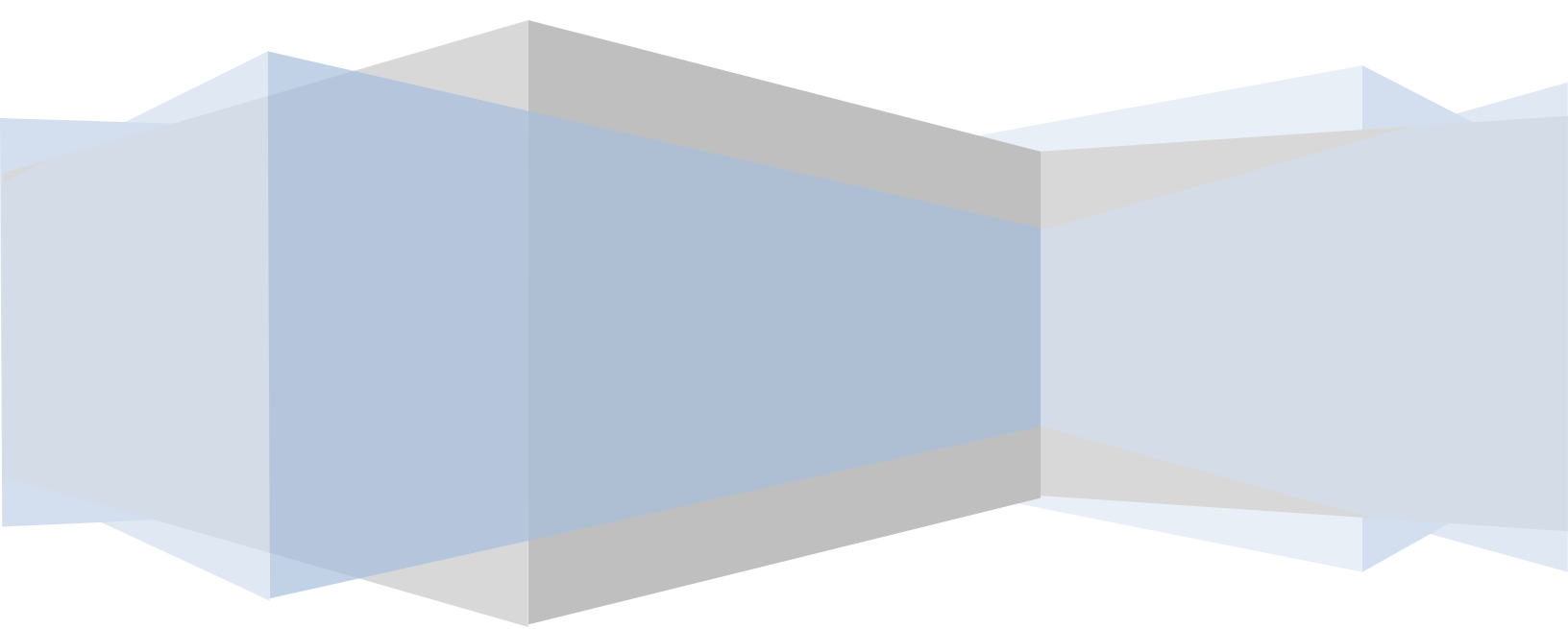

EXECUTIVE SUMMARY

The purpose of the Jonesboro Police Department Monthly Report is to compile data into one integrated report for review, allowing for a seamless flow of information for better decision-making. After each department collates their monthly numbers and sends it to the Office of Crime Analysis, it is organized into sections of departmental data, analyzed and packaged, and finally disseminated to department heads, the Chief of Police, the City Mayor, and the City Council. Major sections include Crime Analysis, Emergency 911, Uniform Police Division, Prowl, Criminal Investigative Division, Warrants, Drug Task Force, Traffic, Parking Enforcement, Animal Control, Fleet Maintenance, Records, and Professional Standards.

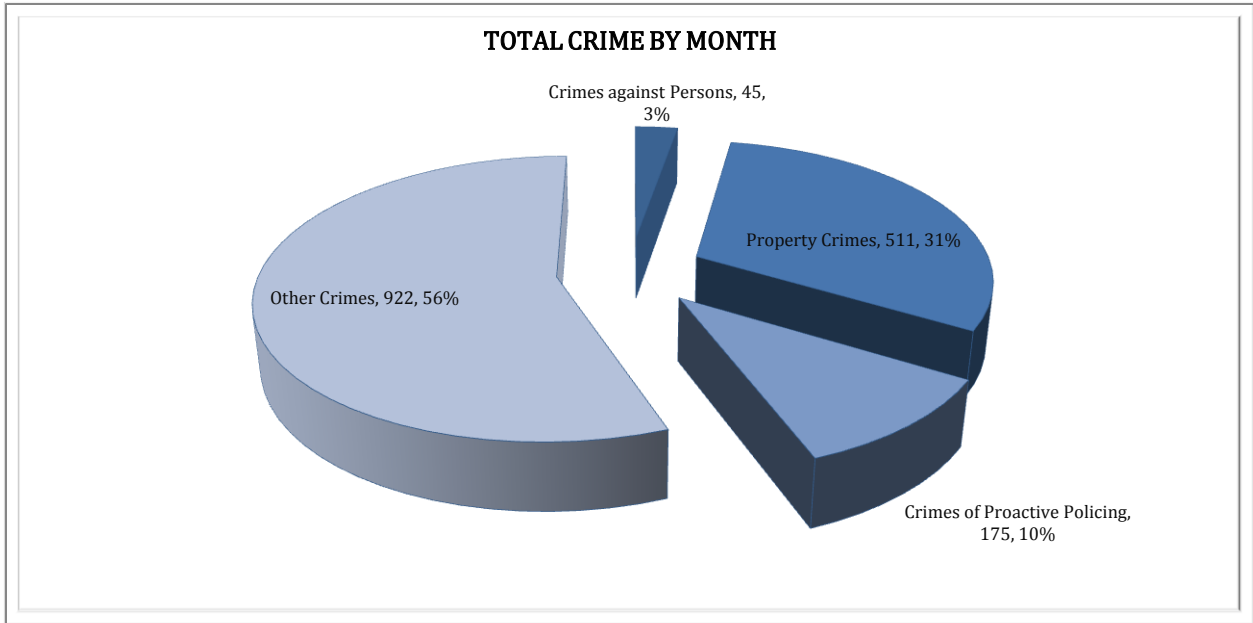
CRIME ANALYSIS

The Crime Analysis division consists of one Crime Analyst and one part-time Crime Analyst Assistant. The Crime Analyst position is responsible for the analysis and dissemination of crime activity data and the collection and maintenance of crime intelligence information for the city of Jonesboro. Additionally, the Crime Analyst is charged with providing the department with current and accurate crime maps, presenting crime activity data to audiences of interest, and responding to requests for crime data from civilians and departmental staff. Data exported from this division is used by field agents for more effective, efficient policing, administration for improved staffing decisions, and the Mayor's office for community decision making and enhanced public relations. The following section is broken down into Total Crime, Crimes against Persons, Property Crimes, Crimes of Proactive Policing, Other Crimes, and Arrest Demographics.

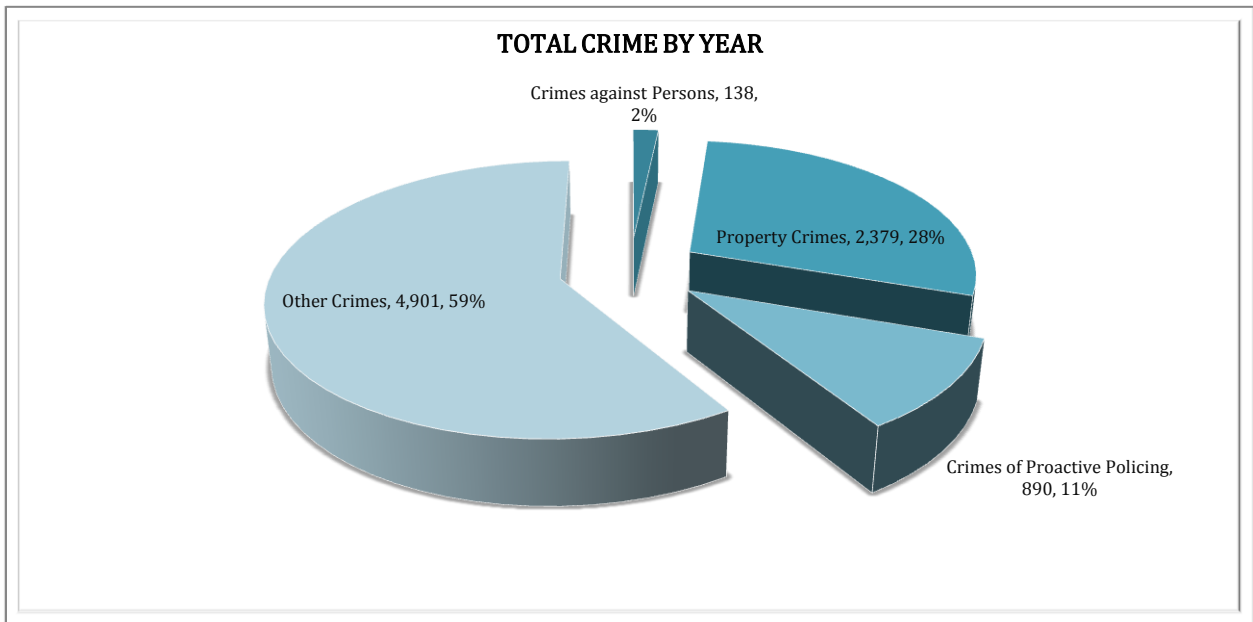
TOTAL CRIME

The crime activity for the month of May, 2011, is at a total of 1,653 offenses, up from 1,632 offenses in last May, a 1% increase. With Jonesboro population equal to 67,263, the crime rate is 24.58 crimes per 1,000 population for the month of May this year, compared to the 25.35 crimes per 1,000 population last year, a 3% drop*. As indicated on a pie chart on the following page, Other Crimes absorb the majority, 56%, of this month's crime activity ($n = 922$). Property crimes fall in second place and are at 31% ($n = 511$). Following in third and fourth places are crimes of proactive policing at 10% ($n = 175$) and crimes against persons at 3% ($n = 45$).

* Note: 2010 numbers are based on 2010 population estimate = 64,374.

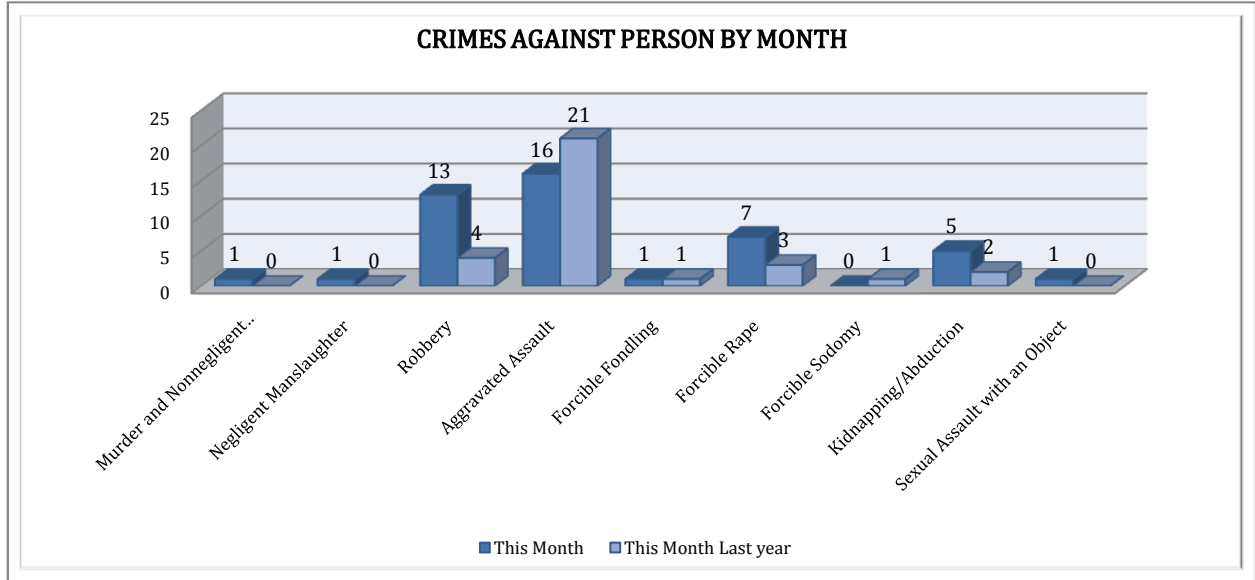


Year to date data includes number of crimes from January through May, of which there is a total of 8,308 offenses, up from 7,638 offenses of the last year's May, a 9% increase. Again, Other Crimes have the highest percentage of total crimes and are at 59% ($n = 4,901$). Similar to this month's data, Property Crimes take second place at 28% ($n = 2,379$). Following are the crimes of Proactive Policing at 11% ($n = 890$) and crimes against persons at 2% ($n = 138$).

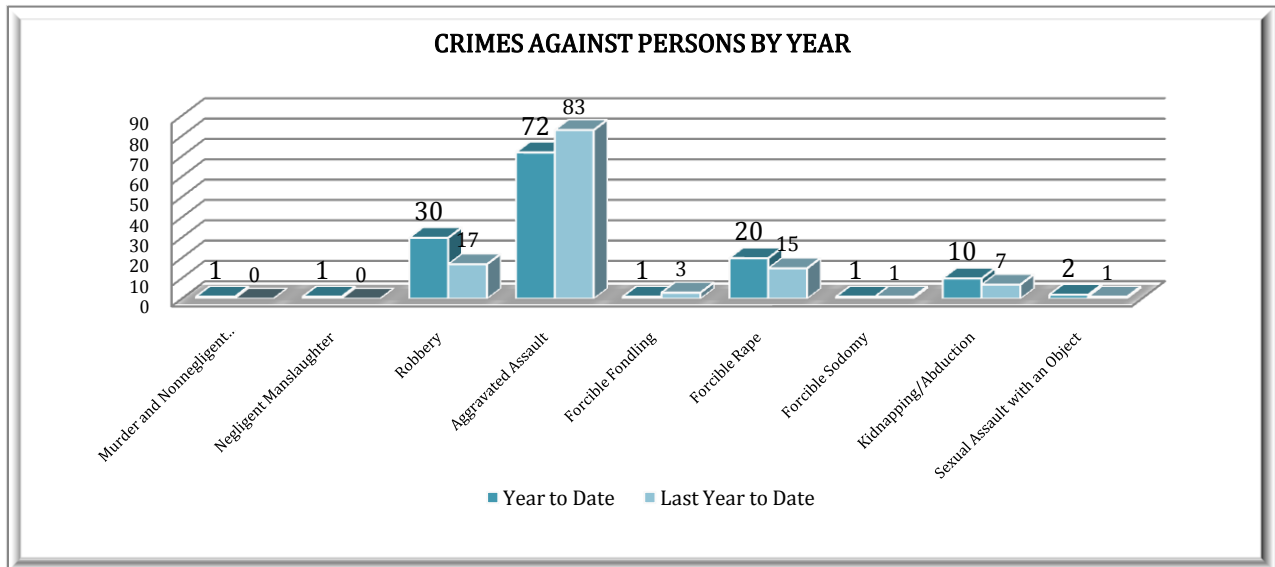


CRIMES AGAINST PERSONS

There are 9 crimes that make up this section. There were a total of 45 offenses in this area this month, a significant, 45% increase from the last year's data. This increase is mainly related to rise in robbery and rape offenses frequencies. The following chart demonstrates this month's activity compared to May of last year's activity.

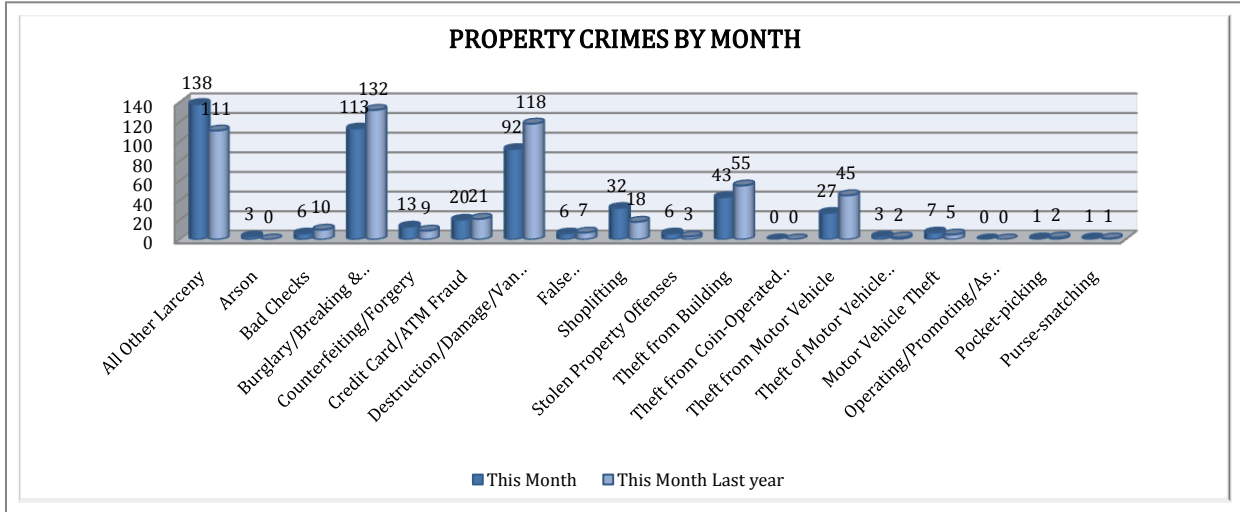


Bellows bar graph indicates the year to date data for Crimes against Persons. Total number of year to date Crimes against Persons this year is 138, up 9% from May last year. As for the year to date total, Aggravated Assaults are down by 13%. Robberies are up by 76% and Forcible Rape increased by 33% this year.

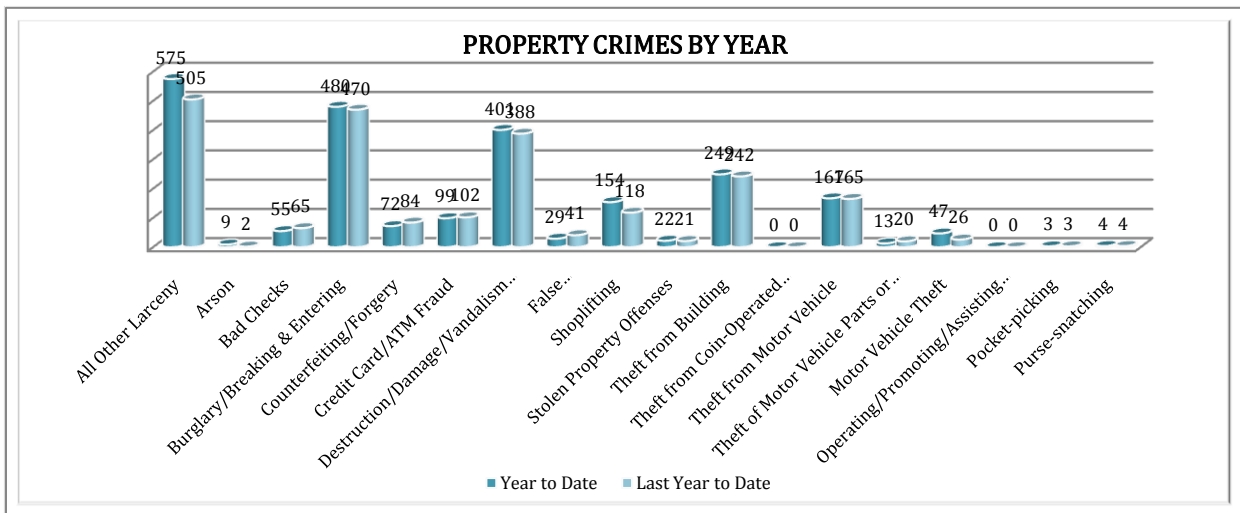


PROPERTY CRIMES

This section displays the criminal activity for 18 crimes, all against property. This month, there were a total of 511 Property Crimes, a 5% decrease comparing to May of last year. The data indicates a 40% drop in Theft of Motor Vehicle, compared to May of 2010. In addition, Destruction/Damage/Vandalism of Property offenses and Theft from Building both are down by 22%; Burglary/Breaking and Entering crimes show a 14% decrease. All Other Larceny shows 24% increase comparing to May of last year.

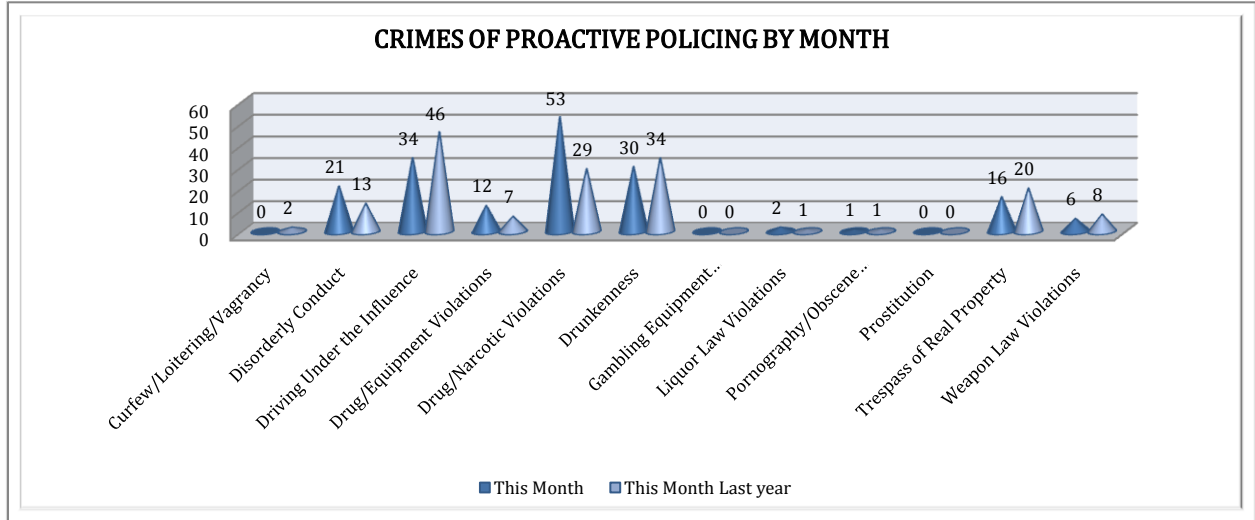


To date this year, 2,379 property offenses have occurred; the data indicates a 5% increase in change when compared to last year's data at this same time. There is a noticeable 29% drop in False Pretenses/Swindle/Confidence Game offenses; Bad Checks are down 15%, Counterfeiting/Forgery offenses are down by 14%, and Theft of Motor Vehicle Parts or Accessories category of crime indicates a 35% drop from last year. The Motor Vehicle Theft shows 81% increase when compared to last year. The category of Shoplifting has increased by 31%.

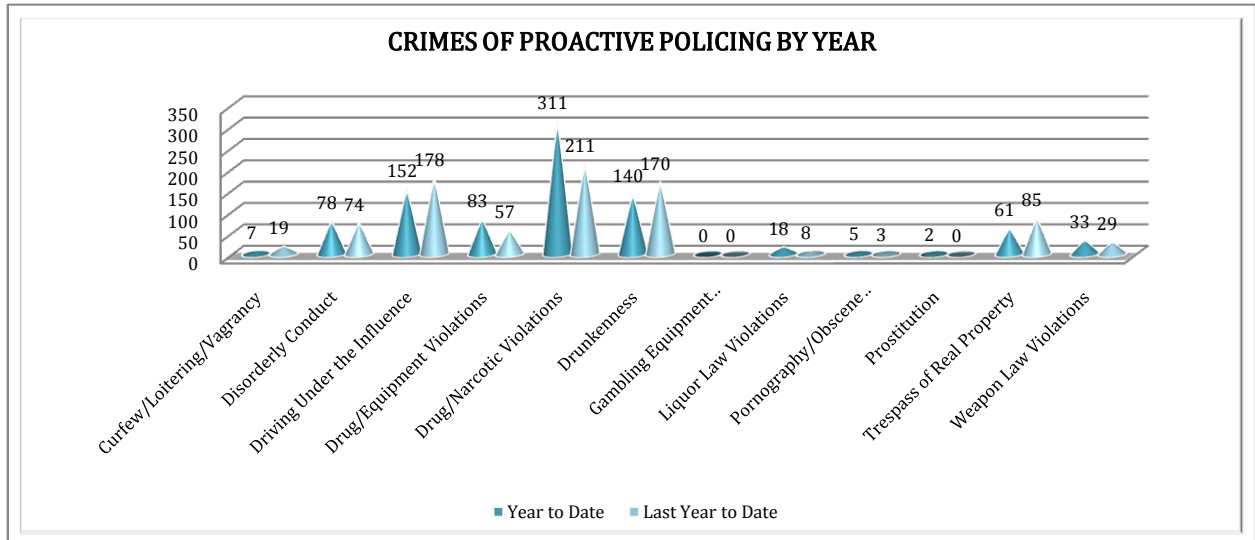


CRIMES OF PROACTIVE POLICING

Crimes of Proactive Policing are those crimes that result from police officers actively policing the streets to combat certain types of street crime. As a chart below indicates, twelve crimes fall under this category. A total of 175 offenses have occurred this month, a 9% increase comparing to May last year. As Drug/Narcotic and Drug Equipment Violations are significantly higher, 83% and 71% increase, respectively, the decrease is evident for Driving Under the Influence (26% down).

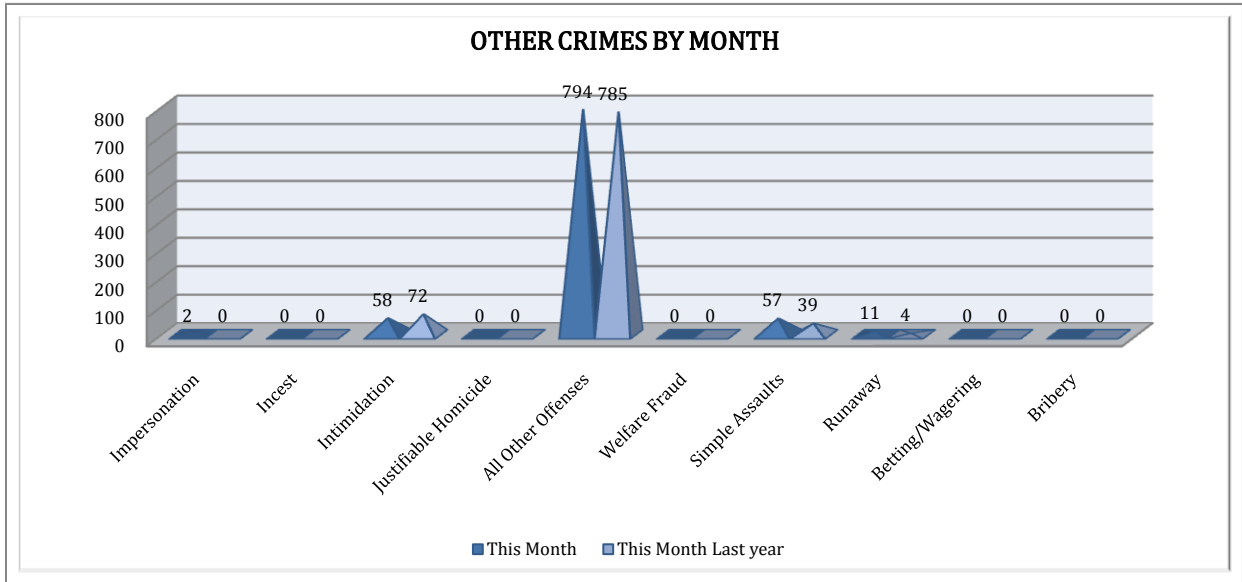


To date for the year 2011, there have been 890 crimes of proactive policing, up 9% from May last year. Again, Drug/Narcotic and Drug Equipment Violations indicate a significant increase within this crime category as they both are up by 47% and 46%, correspondingly. Weapon Law Violations are up 14%. We see an evident drop in Driving under the Influence (15% down), Drunkenness (18% down), and Trespass of Real Property (28% down).

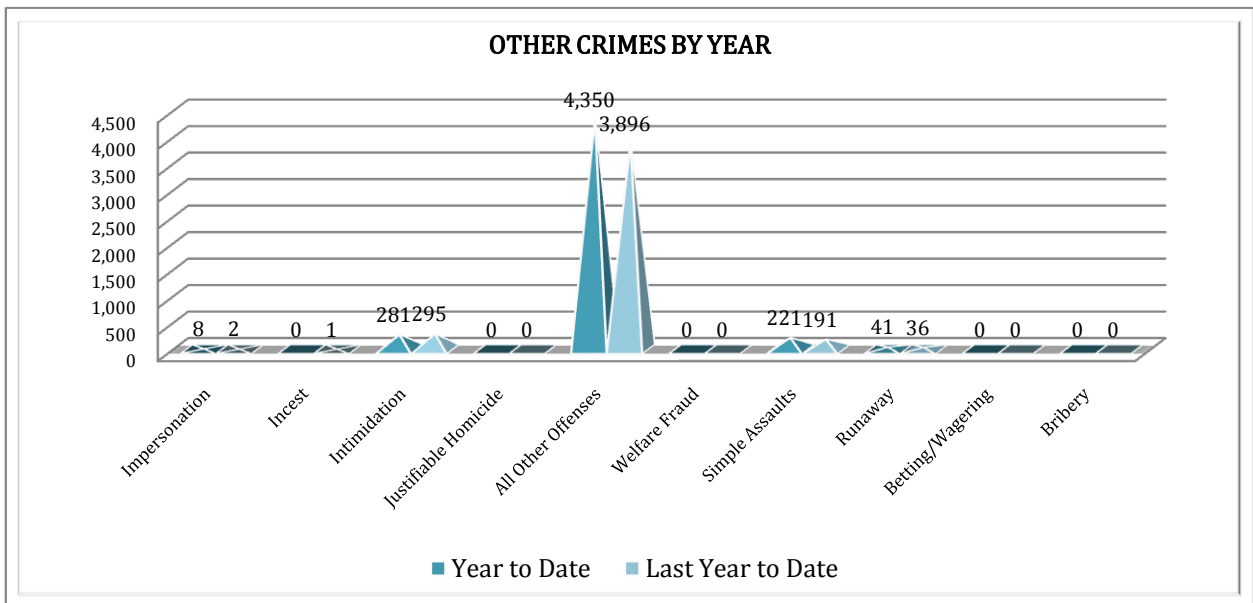


OTHER CRIMES

There are 10 crimes that fall into the Other Crimes category. This month, there have been a total of 922 Other Crimes, up from 900 in last May, a 2% increase. Simple Assaults are up, a 46% increase and so are Runaways, $n = 11$ for this month. Intimidation is down 19% this month, comparing to May of the last year.



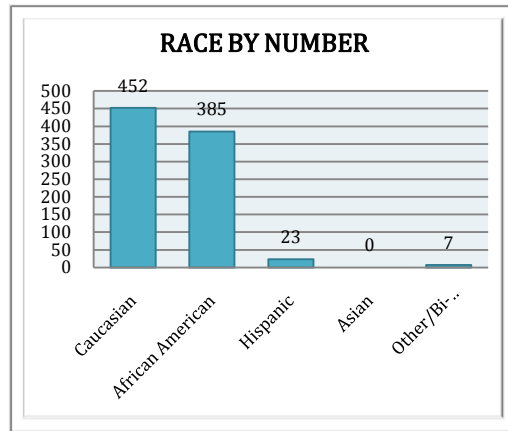
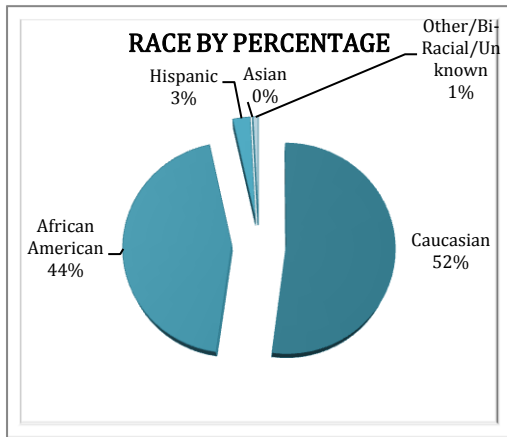
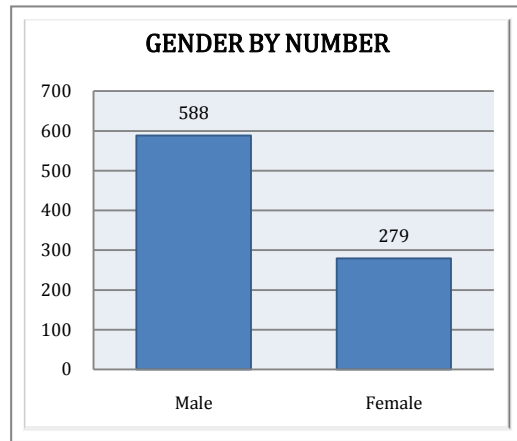
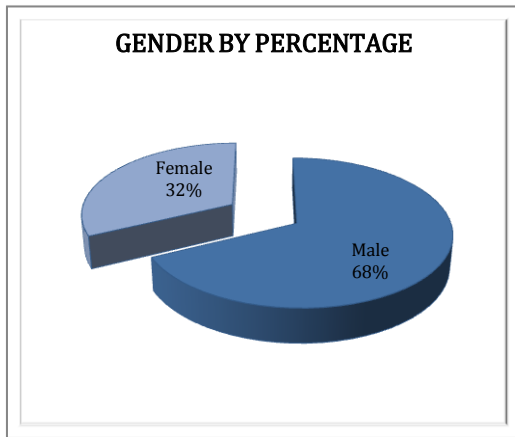
To date this year, there have been 4,901 Other Crimes, up from 4,421 of the last May, an 11% increase. Simple Assaults are up, a 16% increase; Runaways indicate 16% increase and All Other Offenses within the Other Crimes category are up 12% this month, comparing to last year's totals in the month of May.



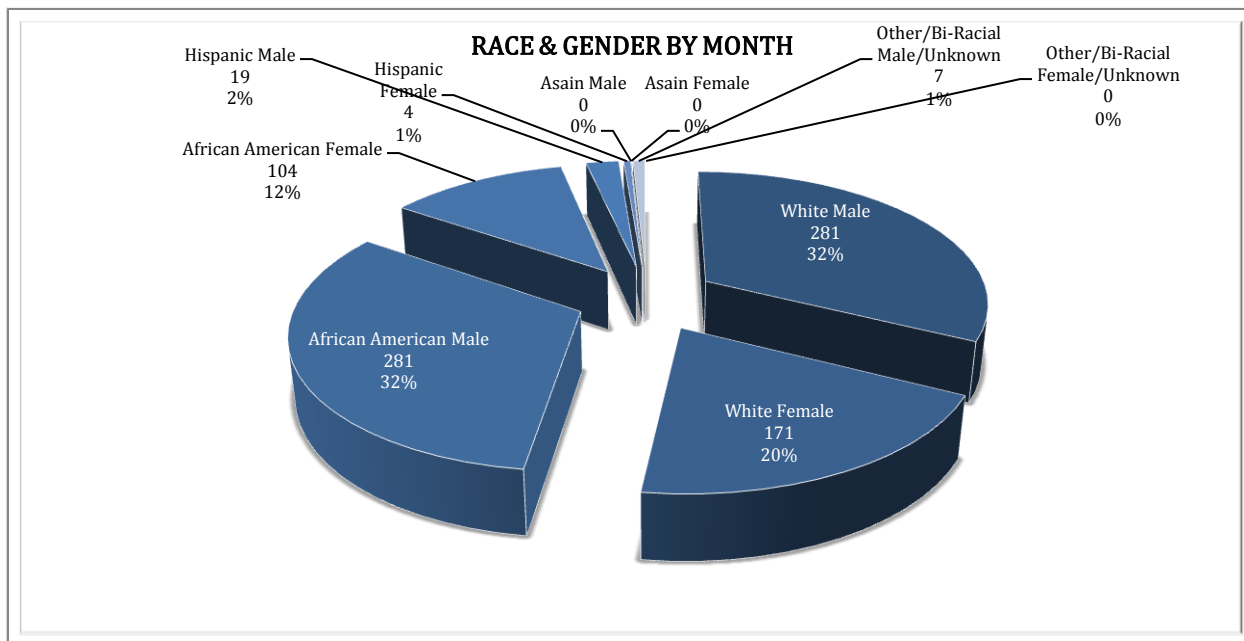
ARREST DEMOGRAPHICS

In May, there were a total of 867 arrests, as opposed to 858 arrests in May of last year, a 1% increase; that is 0.52 arrests per crime in May of this year, indicating no change in arrests rate from the last year.

This section breaks down this month’s arrests by race and gender. The majority of offenders have been male ($n = 588$), as opposed to female ($n = 279$) and Caucasian ($n = 452$) and African American ($n = 385$) as opposed to Hispanic ($n = 23$), Asian ($n = 0$), or other/unknown/bi-racial ($n = 7$).



Both Caucasian and African American males make up the majority of offenders for the month of May, each group category amounting to 32%, where $n = 281$ per race category . Caucasian females make up 20% ($n = 171$) and African American females make up 12% ($n = 104$). Hispanic males make up 2% ($n = 19$). There were also 4 Hispanic Females and 7 Other/Biracial Males arrested in the month of May. This distribution can be reviewed in the pie chart on the following page.

EMERGENCY 911

Also known as Public Safety Answering Point (PSAP), the Emergency 911 Division is responsible for answering all calls from public for emergency assistance, accessing the needed information to best assist, and then assigning the most efficient and effective emergency response. In addition, this division is responsible for setting priority call dispatching to field units including Police, Fire, and EMS. Emergency 911 also maintains all records for radio logs, calls for service, and other emergency service data collections.

UNIFORM PATROL DIVISION

The UPD is responsible for responding to calls into the Emergency – 911 Division by civilians and are normally the first responders. Jonesboro is divided into 6 patrol districts. Officers from UPD are assigned to a district and work the same district every shift. In addition, when a Traffic Officer is not available, a UPD Officer will respond to traffic accidents and assist in directing traffic when necessary.

PROWL

PROWL also assists any division within the Jonesboro Police Department at any time when needed.

On city court days, the Warrants Division provides a bailiff for court and a transport officer. In addition, this Division is responsible for transporting wanted persons arrested in other jurisdictions back to Jonesboro. The STEP program operates within this division and is a grant-funded operation in which officers can get paid overtime to enforce the safety belt law.

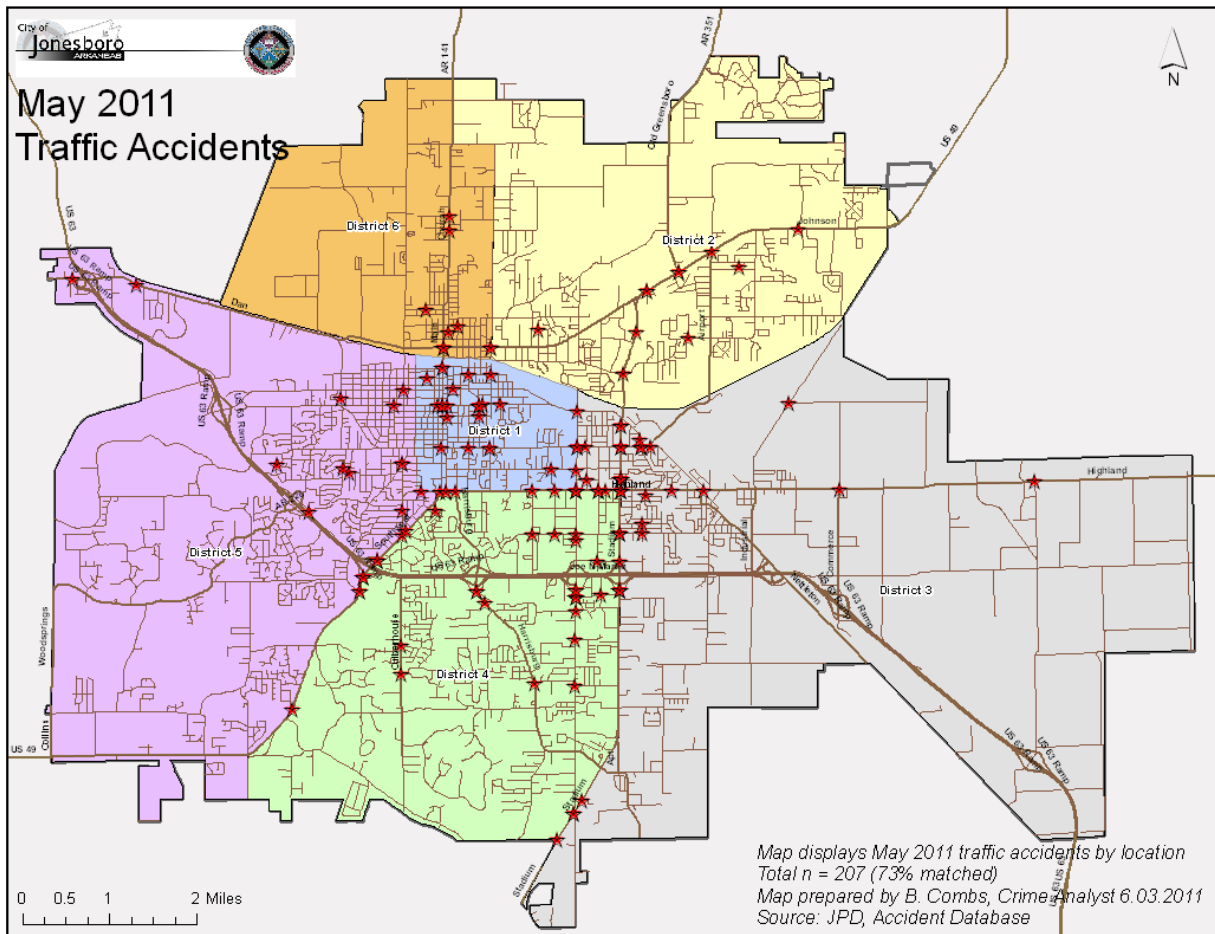

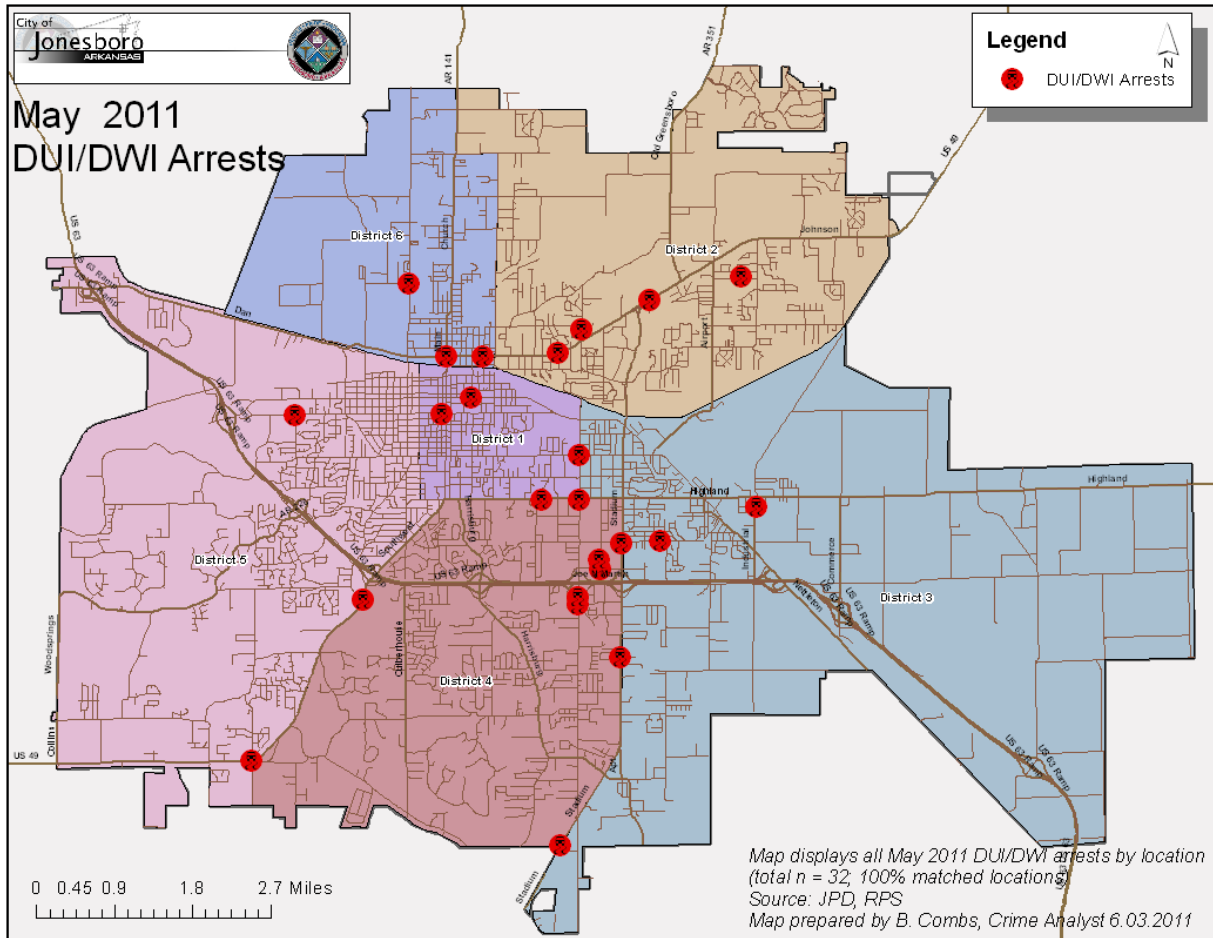
TRAFFIC
