The purpose of the Jonesboro Police Department Monthly Report is to compile data into one integrated report for review, allowing for a seamless flow of information for better decision-making. After each department collates their monthly numbers and sends it to the Office of Crime Analysis, it is organized into sections of departmental data, analyzed and packaged, and finally disseminated to department heads, the Chief of Police, the City Mayor, and the City Council. Major sections include Crime Analysis, Emergency 911, Uniform Police Division, Prowl, Criminal Investigative Division, Warrants, Drug Task Force, Traffic, Parking Enforcement, Animal Control, Fleet Maintenance, Records, and Professional Standards.


CRIME ANALYSIS

The Crime Analysis division consists of one Crime Analyst and one part-time Crime Analyst Assistant. The Crime Analyst position is responsible for the analysis and dissemination of crime activity data and the collection and maintenance of crime intelligence information for the city of Jonesboro. Additionally, the Crime Analyst is charged with providing the department with current and accurate crime maps, presenting crime activity data to audiences of interest, and with responding to requests for crime data from civilians and departmental staff. Data exported from this division is used by field agents for more effective, efficient policing, administration for improved staffing decisions, and the Mayor's office for community decision making and enhanced public relations. The following section is broken down into Total Crime, Crimes against Persons, Property Crimes, Crimes of Proactive Policing, Other Crimes, Arrest Demographics, and Total Crime Monthly Comparison.



TOTAL CRIME

The crime activity for the month of August 2013 was at a total of 1,558 NIBRIS reportable offenses, a 3% increase, comparing to the total of offenses reported in August of the With Jonesboro population last year. estimated to be equal to 69,856, the crime rate in August of this year was at 22 crimes per 1,000 population, comparing to 22 crimes per 1,000 population last year¹, no change. As indicated on a pie chart below, Other Crimes absorb the majority, 52%, of this month's crime activity (n = 812). Property Crimes fall into a second place and comprise of 31% of all the crimes (n = 490). Following in third and fourth places are, respectively, Crimes of Proactive Policing, comprising of 15% (n = 232) of all the crimes, and Crimes against Persons, comprising of 2% (n = 24) of all the crimes this month.




Year to date data includes number of crimes from January through August 2013. A total of 12,140 NIBRIS reportable offenses were reported in 2013, a 4% decrease, comparing to the same period last year. The year to date crime rate amounts to 174 offenses per 1,000 population, compared to 185 offenses per 1,000 population last year (down 6%). To date this year, 53% of all the crimes is attributed to Other Crimes category (n =6,485). Property Crimes amount to 31% of all the crimes (n = 3.718), Crimes of Proactive Policing comprise of 14% of all the crimes to date, where n = 1,721; Crimes against Persons comprise of 2% of a total year to date number of crimes (n = 216).





The line charts below depict frequencies of crime and a monthly and yearly percentage change from the last year.

CRIMES AGAINST PERSONS

There are 9 crimes that make up this section. There were a total of 24 offenses in this area in August this year, a 20% decrease comparing to August of the last year.


Robbery is down 55%. As demonstrated on the bar chart below, there are no other significant changes in frequencies for the crimes in this category.

A bar graph below shows the year to date data for Crimes against Persons, which amounts to a total of 216 incidents for this category of crimes, no change comparing to the year to date data of last year. There is a

75% decrease in Murder and Nonnegligent Manslaughter. Kidnapping/Abduction is up 138%. Forcible Rape is up 57%. There are no other significant changes in frequencies for the crimes in this category.




PROPERTY CRIMES

This section displays the criminal activity for 18 crimes, all against property. This month, there were a total of 490 Property Crimes, a 1% decrease comparing to August of the last year. The data indicates change in Destruction/Damage/Vandalism of Property


(up 14%). Counterfeiting/Forgery is down 60%, Burglary/Breaking & Entering is down 5%, and Theft from Motor Vehicle is up 39% compared to August of last year. No other significant changes are noted this month for this crime category.

To date this year, 3,718 property offenses have occurred, a 7% decrease, comparing to the last year's data at this same time. The following significant changes are noted this year: Credit Card/ATM Fraud is down, -29%; Burglary/Breaking & Entering is down, -15%, Theft from Building is down, -12%, Theft from Motor Vehicle is down -2%, All Other

Larceny is down -3%, and Destruction/ Damage/Vandalism is down - 3%. Stolen Property Offenses are up +88% and so is False Pretenses/Swindle/Confidence Game, up +33%. There are no other statistically significant changes noted for other offenses in this category.



CRIMES OF PROACTIVE POLICING


Crimes of Proactive Policing are those crimes that result from police officers actively policing the streets to combat certain types of street crime. As a chart below indicates, twelve crimes fall under this category. A total of 232 offenses have been reported this month, a 9% increase, comparing to August

of the last year. Drug/Narcotic Violations are up, +50%, Drug/Equipment Violations are up +156%, Disorderly Conduct is down -40%, Liquor Law Violations are up +125%, Drunkenness is down -36%, and Driving under the Influence is down, -25%. Pornography/Obscene Material is up +200%.


There are no other statistically significant changes noted for other offenses in this

category.



To date for the year 2013, there have been 1,721 crimes of proactive policing reported, no change when comparing to the last year's to date data. Drug/Narcotic Violations are up 10%, Drug/Equipment Violations are up 30%, Disorderly Conduct is down 14%, and Drunkenness is up 10%, while Driving Under

the Influence is down 24% and Trespass of Real Property is down 19%. Pornography/Obscene Material is up by 175%. There are no other statistically significant changes noted for other offenses in this category.



OTHER CRIMES


There are 11 crimes that fall into the Other Crimes category. This month, there have been a total of 812 Other Crimes reported, a 4% increase, comparing to August of the last year. Simple Assaults increased by 27% and

Intimidation increased by 15%, while All Other Offenses decreased by 3%. No other significant changes are noted in this category of crimes this month.



To date this year, there have been 6,485 Other Crimes offenses reported, a 4% decrease comparing to the last year's to date data. Intimidation offenses are down 11%, Simple Assaults increased by 18%, and All


Other Offenses decreased by 5%. No other significant changes have been observed for other offenses within this category, comparing to the last year's data.





ARREST DEMOGRAPHICS


In August 2013, there were a total of 930 arrests carried out by the Jonesboro Police Department. Comparing with the last year's data for the month of August, there was a 12% increase in arrests this month, which results in 60 arrests per 100 offenses in August of this year, comparing to 53 arrests per 100 offenses last year, a 6% increase for arrests per 100 offenses. This section breaks down this month's arrests by race and

gender. The majority of arrestees, 69%, have been male (n = 643), as opposed to 31% of female arrestees (n = 287). As for the racial/ethnic composition, the majority of arrestees have been Caucasian (57%) and African American (39%) as opposed to Hispanic (3%), Asian (0%), or other/unknown/bi-racial (1%).










Caucasian males make up the majority, 37%, of arrestees this month (n = 348). African American males make up 28% of arrestees for the month of August (n = 260). Caucasian females make up 19% (n = 179) and African American females make up 11% (n = 101) of arrestees this month. Hispanic

males make up 3% (n = 26), while Hispanic Females make up 0.5% of arestees this month (n = 5). There were o Asain male and 9 Males of unknown race or ethnicity and o Asian female and 2 females of unknown race or ethnicity arested in August.

EMERGENCY 911

Also known as Public Safety Answering Point (PSAP), the Emergency 911 Division is responsible for answering all calls from public for emergency assistance, accessing the needed information to best assist, and then assigning the most efficient and effective emergency response. In addition,

this division is responsible for setting priority call dispatching to field units including Police, Fire, and EMS. Emergency 911 also maintains all records for radio logs, calls for service, and other emergency service data collections.

assigned to a district and work the same district every shift. In addition, when a Traffic Officer is not available, a UPD Officer will respond to traffic accidents and assist in directing traffic when necessary.

responsible for transporting wanted persons arrested in other jurisdictions back to Jonesboro. The STEP program operates within this division and is a grant-funded operation in which officers can get paid overtime to enforce the safety belt law.

The DTF is responsible for investigating major drug traffickers in the area, including all types of illegal drugs.


The DTF works closely with local, state, and federal agencies to eradicate drugs from the community.


